### **2010 Action Plan Update** (In order of strategy and activity)

#### **Strategy 2A:** Educational Updates

- The fall 2010 FIPAC meeting was not approved and has been postponed until the spring of 2011.
  - In an effort to be cost effective, future FIPAC meetings will most likely be held in conjunction with the Emergency Medical Services (EMS) Advisory Council meeting. The next EMS Advisory Council meeting is scheduled for January 2011 in Daytona Beach, FL.
- It was decided that the topics originally selected for the fall 2010 FIPAC meeting educational updates will be carried forward as topics for the next FIPAC meeting.
  - Human Trafficking will be a brief overview and an update on the satellite broadcast.
    - Possibly there could be a local individual present in place of the local (Tampa) stakeholders that Keely Smith had wanted to present.
    - Jan Davis may be able to have Terri Coonin or his local staff present at the meeting.
    - There are also 5 Human Trafficking taskforces across the state that could also be asked to attend and present.

#### **Activity 2B(5):** Pilot Rural Community and State Resources Meeting.

- Since the spring 2011 FIPAC meeting will most likely be held in conjunction with the EMS Advisory Council meeting, it will not be held in Tampa, FL.
- Because of travel restrictions, it is very unlikely that the Rural Pilot would be approved as a free-standing meeting.
